Engagement

Services

- 2. Fix My Credit (Aust) Pty Ltd will:
 - a. If not done already by you, obtain credit reports from credit reporting agencies;
 - b. Write to creditors to negotiate and or remove credit references on your credit report, as instructed by you;
 - c. Communicate with creditors to negotiate and or remove credit references on your credit report;
 - d. Use its best endeavours to provide the above in accordance with all relevant laws;
 - e. Only provide its services if, after the initial interview with you, it believes that there are reasonable grounds to proceed with its credit repair and debt negotiation services;
 - f. Keep you informed and any third party referrer unless you expressly request otherwise.

Fees

- 3. The fees to be paid by you, prior to the commencement of any work are:
 - a. Administration Fee of \$990.00 (incl of GST). This is to be paid prior to the initial commencement of any work on your file;
 - b. Default Removal Fee. This fee is charged for successful removal of each default. The fee for the first default removal is \$660.00 (incl of GST), the

second \$550.00 (incl of GST) for the third and subsequent defaults \$440.00 (incl of GST) each;

- c. Savings Percentage Fee of 12.5% plus GST of the total savings provided to you.
- 4. It is acknowledged that invoicing will reflect the Fix My Credit (Aust) Pty Ltd business trading name of White Label Services Australia so that a reference to a credit repair / debt negotiation entity is not reflected on your bank statements for future financial enquiries.

Client Undertakings

- 5. You agree not to enter into any further financial arrangements or apply for finance while Fix My Credit (Aust) Pty Ltd is engaged. If you need to get financial aid or a loan to assist with the restructure of your debt portfolio, you must notify Fix My Credit (Aust) Pty Ltd as it may be able to provide assistance or recommend a number of brokers that could assist you.
